**MOTION TO CONTINUE HEARING OF
THE EAST OHIO GAS COMPANY D/B/A DOMINION EAST OHIO**

In accordance with Ohio Adm. Code 4901-1-12(A) and 4901-1-13(A), The East Ohio Gas Company d/b/a Dominion East Ohio (DEO or the Company) respectfully requests that the Commission continue the hearing scheduled for April 7, 2017. Good cause exists to grant this motion for the following reasons.

The March 1, 2017 Entry set a hearing date of April 7, 10:00 a.m. Both DEO's counsel and witness have a prior conflict on April 7 and would not be able to attend were a hearing to be held on that date. DEO accordingly requests that the Commission reschedule the hearing either to April 6 or to April 10, 2017, with a preference for April 6. While this may require other adjustments to the procedural schedule, DEO would request that the current deadlines for Staff and intervenors to file comments and for the parties and Staff to file expert testimony (March 24 and April 3, respectively) remain the same.

DEO has consulted with counsel for the Commission Staff, and Staff has no objection to this request. For the foregoing reasons, DEO respectfully requests that the Commission reschedule the April 7 hearing to one of the specified dates and grant any other necessary and proper relief.
