- {¶ 1} By Entry dated March 1, 2017, the above-referenced case was scheduled for hearing on April 7, 2017, in the event that all of the issues are not resolved through the parties' comments or the parties enter into a stipulation.
- {¶ 2} On March 8, 2017, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO or Company) filed a motion to reschedule the hearing date. In support of the motion, DEO states that its counsel and witness have a prior conflict on April 7, 2017, and would not be able to attend were a hearing to be held on that date. Accordingly, DEO requests that the Commission reschedule the hearing either to April 6 or April 10, 2017, with a preference for April 6, 2017. DEO states that, while this rescheduling may require other adjustments to the procedural schedule in the case, the Company requests that the current deadlines for Staff and intervenors to file comments and for the parties and Staff to file expert testimony (March 24, 2017, and April 3, 2017, respectively) remain the same. Further, DEO states that it has consulted with counsel for Staff, and Staff has no objection to this request.
- {¶ 3} In view of the circumstances, the attorney examiner believes that the hearing date for this case should be rescheduled in order to avoid a schedule conflict with a prior commitment of DEO's counsel and witness.
- {¶ 4} Accordingly, the hearing in this matter should be rescheduled on April 6, 2017, at 10:00 a.m., in hearing room 11-C, in the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215.

{¶ 5} The attorney examiner notes that the procedural deadlines of March 24, 2017, for Staff and intervenors to file comments, and April 3, 2017, for the parties and Staff to file expert testimony, will remain the same.
