On March 2, 2017, Hog Creek Wind Farm LLC ("Hog Creek") submitted an application to amend ("Amendment Application") the merged certificate issued in Case Nos. 16-1422-EL-BGA and 16-1423-EL-BGA. The Amendment Application sought to permit Hog Creek to construct a meteorological tower and to construct an access road to the tower as part of the project.

With the filing of this notice, Hog Creek hereby withdraws the Amendment Application. Hog Creek will continue to abide by the terms and conditions of the merged certificate issued by the Ohio Power Siting Board on November 29, 2016.<sup>1</sup>
