Dear Mr. Donlon and Ms. McNeal:

This letter serves as Dominion East Ohio's ("Applicant" or "DEO") pre-application notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the proposed Line 4265 (2017) mainline extension and regulation installation project, City of Youngstown, Mahoning County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Construction Notice.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-6-03(A), DEO provides the following information:

Project Description: DEO is planning to install 1,127 feet of 12-inch diameter natural gas pipeline (Line 4265) in a north to south direction at the intersection of Francisca Avenue and Guadalupe Avenue within the City of Youngstown, Mahoning County, Ohio, and will be within DEO's existing right-of-way and easement. DEO also proposes to install a regulation station that will allow pressure to be reduced to supplement its lower pressure systems.

Anticipated Project Schedule: The construction of the pipeline is anticipated to begin in July 2017. DEO plans to place the line in-service by September 30, 2017.

Expedited Treatment: DEO requests expedited treatment for this application, and will submit payment of \$2,000 in accordance with OAC Rule 4906-6-04(A)(2).
