Pursuant to Gov. Bar. R. XII, Gregory E. 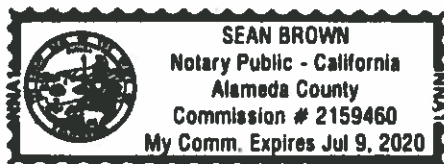


