#### DAYTON POWER AND LIGHT COMPANY'S MOTION FOR CONTINUANCE

Pursuant to Rule 4901-1-13 of the Ohio Administrative Code, The Dayton Power and Light Company ("DP&L" or "the Company") hereby moves the Public Utilities Commission of Ohio ("Commission") for a continuance of the settlement conference scheduled for April 4, 2017. On February 24, 2017, the Attorney Examiner issued an Entry scheduling a settlement conference for this case at 10:00 a.m. on April 4, 2017. Subsequently, on March 8, 2017, the Attorney Examiner in Case No. 16-395-EL-SSO issued a scheduling order whereby the hearing on DP&L's electric security plan ("ESP") will commence on April 3, 2017. DP&L's counsel of record in this case is also counsel in the Company's ESP case. It is a near certainty that DP&L's ESP hearing will not be concluded prior to the settlement conference in this case.
