
As a resident of Lakewood, very near the proposed wind farm site, I am completely in favor of this project. Each time I visit my home state of Iowa, I see new evidence of the great potential market for wind energy. In Ohio, we arguably have even bigger possibilities open to us. Offshore winds are stronger and more consistent, and could move this technology from the margins toward the mainstream of energy production.

Ohio also has a manufacturing base that could greatly benefit from exercising leadership on offshore wind development. As the United States' second offshore wind farm, and the first freshwater wind farm in North America, Icebreaker is a valuable opportunity to make Ohio a center for offshore wind investment and jobs.

I am satisfied by evidence that Icebreaker wind farm will have minimal impact on Lake Erie wildlife, and that the opportunity to learn more from this demonstration project solidly justifies its approval. We know for certain, meanwhile, that nonrenewable power sources play a big part in greater Cleveland's poor air quality—building up clean alternatives like offshore wind will have a dependable positive impact on our community's health.

There are so many reasons to support the initial offshore wind project on Lake Erie, it would be hard to list them all!

Wind power in general will be an essential source of clean renewable energy for the future. We should put up installations as fast as possible. Offshore wind power has the extra advantage of being particularly steady and strong - just a few miles from shore.

Cleveland has the luxury of being adjacent to this source of power. And Lake Erie should really be the first of the Great Lakes to host such an installation, since the lake bottom is relatively flat, and the water is very shallow - about sixty feet at the deepest. So it will be much easier to lower and secure the bases. The suction

buckets to be deployed by Dominion Power is an exciting new technology - presumably setting the stage for use in future installations.

The environmental impacts are all positive. the Danes, twenty years ago, discovered via radar studies, that birds are smart and fast enough to navigate through, or around, wind installations. So modern wind turbines pose no threat. In fact, if they divert some species from their traditional migration routes, they may save those species from being targeted by the waterfowl hunters!

The positive impact on manufacturing, and jobs will be great. This Renaissance will show leadership to other communities - nationwide and internationally.

By installing Lake Erie's first offshore wind project, Cleveland has the opportunity to show where we should be going - in order to help save our planet.




