Memorandum in Support

US Energy Consulting Group, LLC, (“Movant”) requests a thirty day extension of its Certificate No. 13-684E (2) which was issued by the Commission on April 28, 2015, bearing an expiration date of April 27, 2017. Pursuant to Ohio Admin. Code 4901:1-24-09(A), its renewal application was due to be filed no less than thirty days prior to the expiration date indicated on its CRES provider certificate, or March 28, 2017. Movant respectfully requests the additional time required to complete the preparation of supporting exhibits for its renewal application.

Rule 4901:1-24-09(B) provides in pertinent part: “Any renewal application filed fewer than thirty calendar days prior to the expiration date indicated on the certificate, but no later than the expiration date on the certificate, shall be filed with a motion requesting an extension of the certificate. If the motion is filed in conformance with rule 4901:1-24-07 or 4901:1-24-13 of the Administrative Code, it shall be deemed automatically approved unless, within three business days of its filing, the commission or an attorney examiner appointed by the commission rules otherwise.”

Movant submits that no one will be prejudiced by the thirty day extension requested herein, and the additional time permitted Movant to complete the necessary supporting exhibits. This motion is filed in conformance with Ohio Adm. Code 4901:1-24-07.

For the above reasons, US Energy Consulting Group, LLC, respectfully moves that its Certificate No. 13-684E (2) be extended automatically for thirty days as permitted in Rule 4901:1-24-09(B).
