

Customer Notice and Affidavit

(Customer Notice)

The following customer notice will appear on the bills that are mailed to customers on April 1, 2017. This notice will also be sent to the Office of Consumers' Counsel and to the Commissions' electronic mailbox (Telecomm-Rule07@puc.state.oh.us) no less than thirty (30) days prior to the rate increase.

Effective June 1, 2017, our local telephone rate for residential customers will increase by \$1.25 per month as listed in the table below. Many rural telephone companies, including Champaign Telephone Company, receive support from the Federal Universal Service Fund (FUSF). New rules reduce such support if a telephone company's local rates are below the national average. The \$1.25 increase is necessary to bring our residential local rates more in line with the national average and to avoid reduction in our FUSF.

• **Effective May 1, 2017**, the amount of the Federal Universal Service Charge (FUSC) will increase as a result of an increase in the Federal Universal Service Fund (FUSF) contribution factor. The new FUSC amount is calculated by multiplying the FUSC surcharge and the multi-line business end user common line FUSC surcharge factors by the applicable Interstate Access Service charges on your bill.

• **Effective May 1, 2017**, CT will have a rate increase for all Residential customers who are NOT currently under a monthly agreement. *If you have an agreement, your rates will remain locked-in to what they currently are for the remainder of your agreement.* Please be aware that the standard rate increase, which is service and feature specific, will only affect the non-contractual customers.

• **Effective June 1, 2017**, a rate increase of \$1.25/month (as listed in the table below) will be applied on your TELEPHONE rates only for all CT Residential customers who are NOT currently under a monthly agreement. Many rural telephone companies, including CT, receive support from the Federal Universal Service Fund (FUSF). New rules reduce such support if a telephone company's local rates are below the national average.
