I have worked on a windmill farm in Payne Ohio out of Toledo, and it instantly made me a believer of the benefits and rewards. Each windmill generates about 1-1.5 megawatts of power at the cost of about 1.1 million dollars. Dollar for dollar it costs less to build per megawatt then a gas turbine powerhouse. Typically, a 550 megawatt gas turbine powerhouse will cost about 1-2 billion dollars. Unlike power plants, they are pretty much maintenance free.

I know there are folks out there that want to go back to the horse and buggy because you don't need to wear a seat belt. Let me assure you that this way of thinking is just plain nuts. Let's ALWAYS go forward with progress, future generations are counting on us.
