## Ohio Edison Company The Cleveland Electric Illuminating Company The Toledo Edison Company (FirstEnergy) Case No. 17-338-EL-RDR

## **Background**

On March 17, 2017, First Energy filed its proposed Rider GEN tariffs in Case No. 17-338-EL-RDR. The proposed tariffs were filed in response to and in compliance with the Commission Opinion and Order in Case No. 14-1297-EL-SSO dated March 31, 2016 (ESP IV Order), the Finding & Order dated May 25, 2016 in Case No. 16-541-EL-RDR and Finding & Order dated February 8, 2017 in Case No. 16-936-EL-UNC.

The proposed tariffs include Standard Service Offer (SSO) generation rates, Time of Day (TOD) generation rates and Percentage of Income Payment Plan (PIPP) generation rates. The proposed SSO and TOD rates include the results of the most recent auction held January 31, 2017, approved by the Commission on February 2, 2017. The proposed PIPP generation rate reflects the results of the PIPP auction held February 6, 2017 and approved by the Commission on February 8, 2017.

The Proposed tariffs will become effective on June 1, 2017.

## **Staff Review and Recommendations**

Staff has reviewed the proposed tariffs filed on March 17, 2017, and finds that the tariffs appear to be in compliance with Commission Orders and accurately reflect the January 31, 2017, and February 6, 2017, auction results.

## **Conclusion**

The Staff recommends that the proposed tariffs filed on March 17, 2017, be approved and become effective on a services rendered basis on June 1, 2017.
