

MOTION FOR EXTENSION

Pursuant to Rule 4901:1-24-09(B) of the Ohio Administrative Code, Broadleaf, LLC dba Broadleaf Energy ("Broadleaf Energy") seeks an extension of Certificate No. 13-690E (2) which was issued in Case No. 13-792-EL-AGG. The expiration date of Certificate No. 13-690E (2) is May 3, 2017. Due to lack of familiarity with the deadline, Broadleaf Energy did not file its renewal application on time. It filed its renewal application on April 14, 2017 which is nineteen calendar days before the May 3, 2017 expiration date. 
