**MOTION TO CONTINUE HEARING OF  
VECTREN ENERGY DELIVERY OF OHIO, INC.**

In accordance with Ohio Adm. Code 4901-1-12(A) and 4901-1-13(A), Vectren Energy Delivery of Ohio, Inc. (VEDO or the Company) respectfully requests that the Commission continue the hearing scheduled for August 3, 2017. Good cause exists to grant this motion for the following reasons.

On May 1, 2017, VEDO filed an application for authority to adjust its Distribution Replacement Rider charges, in accordance with a stipulation signed by VEDO and Staff and approved by the Commission in Case No. 07-1080-GA-AIR. On May 5, 2017, the attorney examiner in this case issued an Entry setting a hearing date of August 3, 2017, at 10:00 a.m. One of VEDO's witnesses, Steven Hoover, has a prior conflict on August 3 and would not be able to attend were a hearing to be held on that date. VEDO accordingly requests that the Commission continue the hearing to any day of the following week, the week of August 7. VEDO has no conflicts with the remainder of the procedural schedule.

VEDO has consulted with counsel for the Commission Staff, and Staff has no objection to this request. For the foregoing reasons, VEDO respectfully requests that the Commission continue the August 3 hearing to any day of the week of August 7 and grant any other necessary and proper relief.
