Lady Indians hold off a New Boston comeback for sectional semifinal victory

While the Western Lady Indians have a tall task in front of them, they don't have any intentions of backing down from the opposition.

With a 6-5 Division IV sectional semifinal win at New Boston Monday evening, the Lady Indians will be headed to Leesburg Fairfield Thursday evening for a sectional final battle with the seventhranked Lady Lions.

Plating three runs in the second inning was crucial for giving Western a cushion throughout the game. Jordyn Haggy started by reaching base on an error with one out and stole her way around the bags to score. Chelsey Penwell reached on a single and did the same. Jadah Peason also worked a walk and later accounted for the third run of the frame, 3-0. Defensively. Western recorded three straight groundouts in the bottom of the third inning to keep New Boston from even having a base runner.

Western senior Destiny Montgomery led off the top of the fourth inning by doubling to left center field before Haggy was hit by a pitch to put runners at first and second. Penwell reached on a fielder's choice that saw Montgomery out at third. Then Pearson hit into a double-play to bring the inning to a close.

The Lady Tigers broke up the shutout by capitalizing on a walk in the bottom of the fourth inning. Mariah Buckley worked the leadoff walk and came around to score on a single from Taylen Hickman, 3-1.

Boston any momentum, Western battled back with two runs in the top of the fifth to take a four-run lead. Shalee Gray worked a one-out walk and went to second when a wild pickoff throw from the New Boston catcher sailed into right field. Then Katlyin Hughes reached base on an error, allowing Gray to score. Hughes then went home on a single from Haley Whitt, 5-1.

Western needed all of those runs to hold onto the lead, as the Lady Tigers came back with three in the fifth frame. A walk and a single put runners at the corners for New Boston before a grounder back to Haggy created the first out. Another grounder plated New Boston's first run of the frame.

Then a single followed to plate the second run. The third run scored on a Western error, trimming the lead to 5-4.

Once again, the Lady Indians managed to give themselves a cushion, coming back with their final run in the top of the sixth. Haggy led off the inning with a triple down the left field line. She then scored on a fielder's choice with one out, 6-4.

The Lady Tigers cut the lead to one for a final time in the bottom of the sixth, using a walk and a double, 6-5.

Western hoped to add more runs in the top of the seventh after Kylie Tong reached base on an error with one out. However, it wasn't to be as the next two batters hit fly balls to end the inning.

The Lady Indians responded with a 1-2-3 inning defensively to seal the win. The first batter connected on a hard hit ball to center field, only to have Penwell snag it with a leaping catch. Then Haggy got the next batter on strikes. Tong, the catcher, collected the final out by securing a pop-up in foul territory along the third base line to seal the 6-5 win.

"I'm very proud of our effort and improvement," said Western coach Mick Whitt. "Fairfield will be a tough opponent for us, but we aren't going to back down. They still have to hit, pitch and play defense, just like us. Right now, we are as confident as we have been all year." From the plate, Whitt went 2-for-4 with one RBI. Montgomery was 1-for-4 with her double. Pearson did not have a hit, but collected one RBI. Penwell was 1-for-3 with a run and three stolen bases. Defensively, she tracked down three fly balls, including one that was tipped by right fielder Hughes. Penwell was there for the backup, securing the tipped ball before it touched the ground.

"Chelsey is the kind of athlete who could play anywhere. I could really put her at any position. She played shortstop when we had some players missing. She is as good as any of the outfielders we see. She's fast and she has a good arm," said Whitt.

"I want to recognize Jordyn Haggy because she pitched a great game. A big key tonight for us was our base running. We were able to take advantage of our opportunities."

Haggy gave up five runs on five hits, while striking out three batters, walking five and hitting one. From the plate, she was 1-for-3 with a triple, three stolen bases and two runs.

IN REGULAR SEASON ACTION ...

Continuing their improvement on the softball field, the Western Lady Indians recently split their season series with the Green Lady Bobcats before following with a victory over Sciotoville East.

Western's offense was strong in the two victories as both were the run-rule variety. After suffering a 5-1 loss in the game at Green on April 26, the Lady Indians returned home on April 28 and blasted



the Lady Bobcats with a 15-5 win. Then the Lady Indians followed that effort with a 17-7 conquest at East on Wednesday, May 3.

In the Wednesday, April 26 loss at Green, Western's only run came across in the top of the fifth inning when Jessica Stevens led off by reaching on an error and eventually making it around to score on a sacrifice fly from Kylie Tong. At that point, Green had already scored five runs, making it 5-1, by plating four in the second and one in the fourth.

Destiny Montgomery was the leading hitter for Western, going 2-for-2, while Haley Whitt was 2-for-4. Tong was 1-for-4 with the lone RBI, while Stevens was 1-for-3 with a run. Jadah Pearson and Jordyn Haggy each finished 1-for-3 as well. Jordyn Haggy suffered the pitching loss, striking out three and walking two.

Just two days after that loss, the Lady Indians came back with their 15-5 win at home over the Lady Bobcats.

It took Western's offense a while to get going, as the Lady Indians found themselves down 2-0 after three innings of play.

The Lady Indians started their come-from-behind rally with two outs in the bottom of the fourth inning. Haley Whitt reached base first on a walk before Kylie Tong followed with a double. Then Chloe Legg provided a single to send both of them home, 2-2.

Green reclaimed the lead briefly with three runs in the top of the fifth inning, 5-2.

AEP Ohio Transmission Company, Inc., (AEP Ohio Transco), an affiliate of AEP Ohio, proposes to rebuild a138-kilovolt (kV) transmission line in Pebble, Benton and Sunfish townships in Pike County and Franklin, Meigs, and Scott townships in Adams County. The project is known as the Ware Road-Seaman 138kkV Transmission Line Project.

The purpose of the project is to improve electric transmission service reliability in Pike and Adams counties. The project involves replacing about 30 miles of aging wood structures with single pole, steel structures. This project will be an approximate \$45 million investment by AEP Ohio Transco. Construction is scheduled to begin in August 2017.

AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board, under Case No. 17-0813-EL-BLN. This number should be included in all communications with respect to this project. The Letter of Notification to construct, operate and maintain this transmission line is pending before the board.

Petitions to intervene in the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. 
