Dear Commission:

This Letter of Compliance is being filed pursuant to the Commission's Entry on April 26, 2017 in Case No. 10-2387-TP-COI. Please be advised that Vision CTS ("VCTS" or "Company") has no revisions to make to its Ohio PUC Access Tariff No. 1 ("Tariff"). The FCC's sixth phase of intrastate access reductions, which are to occur no later than July 1, 2017, instruct CLECs to reduce intrastate access terminating switched end-office rates and reciprocal compensation. Page 48 of the VCTS Tariff benchmarks the Company's switched access rates to the rates of the underlying carrier of the area. Due to this, there is nothing in the VCTS Tariff to revise.
