Mr. Schneider,

I am currently reviewing your Ohio natural gas broker application and have found a couple of potential issues with the application. I am responsible for reviewing Exhibits A, B and D while other staff review Exhibit C. Staff reviewing the other section may contact you if the information provided does not satisfy the application certification requirements.

The potential issues include filing the application on the wrong form. You filed the application on the supplier (CRS) form instead of on the broker/aggregator (AGG) form. Since the forms are very similar I will work with docketing to try to get your case designation changed from supplier to broker. The other issue is Exhibit A-7 where under Toll-free Telephone No. your answer was "Collect". Since you are applying to be a broker and not a supplier you do not need a toll-free phone number but a phone number is required. The phone number to complete A-7 should be provided as soon as possible. Please send the revised page directly to the docketing division (not to me) along with a brief cover letter explaining the filing. Please include your case number, 17-1287-GA-AGG on all documents sent to docketing.
