- {¶ 1} A prehearing conference was held in this case on May 23, 2017. At the prehearing conference, a hearing date of July 20, 2017, was established.
- {¶ 2} Accordingly, this case should now be scheduled for hearing on July 20, 2017, at 10:00 a.m., at the offices of the Commission, in Hearing Room 11-D, 180 East Broad Street, Columbus, Ohio 43215-3793.
- {¶ 3} Ohio Adm.Code 4901:2-7-14(E) provides that a respondent who has requested an administrative hearing and fails to participate in the hearing proceeding shall be in default. The rule additionally states that a respondent in default shall be deemed to have admitted the occurrence of the violation and waived all further right to contest liability to the state for the forfeiture described in the notice.
- {¶ 4} Following Staff's presentation of evidence at the hearing, it shall be the responsibility of the Respondent, Planet Freight, LLC, to present evidence in support of its contentions regarding the alleged violations in this matter.
- {¶ 5} Ohio Adm.Code 4901-1-08 requires that all corporations must be represented in Commission proceedings by an attorney-at-law authorized to practice in Ohio.
- {¶ 6} Pursuant to R.C. 4901.14, a regular salaried employee of a directly concerned corporation may appear before the Commission in the determination of transportation matters involving questions of fact only. However, such an employee cannot act as an attorney. More specifically, such an employee cannot examine witnesses, make motions, or file legal briefs.
