## **Description of the Changes**

In this application, Minford Telephone Company increases its BLES rates for residential and business customers by \$1.00 per month, effective June 1, 2017. By doing so, the Company will move toward the revised universal service "urban rate floor" set in accordance with the FCC's Report and Order and Further Notice of Rulemaking, WC Docket Nos. 10-90, et.at, FCC 11-161 (released November 18, 2011) and the FCC Order on May 18, 2017, adopting a frozen rate floor of \$18 which will apply to support reductions for the period July 2017 through June 2018.

### **EXHIBIT D**

## (Customer Notice and Affidavit)

The following customer notice appeared on bills that were mailed to Minford Telephone Company customers on May 1, 2017. This notice was sent to the Office of Consumers' Counsel and to the Commission's electronic mailbox (Telecomm-Rule07@puc.state.oh.us) prior to the rate increase:

Effective June 1, 2017, your *residential/business* local service rate will increase from the current \$17.00 (residential) per month and \$23.40 (business) per month to \$18.00 (residential) per month and \$24.40 (business) per month. The Federal Communications Commission (FCC) previously issued an order requiring local phone service providers to keep pace with minimum rate floor amounts to avoid forfeiture of certain universal service amounts.

If you are having trouble paying your monthly phone bill, you may qualify for the Federal Lifeline Program which provides discounts to low income customers. For more details on this program, contact our business office at 740-820-2151.
