MEMORANDUM IN SUPPORT

The Northeast Ohio Public Energy Council ("NOPEC"), the Southeast Ohio Public Energy Council ("SOPEC") and Ohio Schools Council ("OSC") (collectively, "Joint Movants") each filed its annual report, pursuant to R.C. 4905.10 on the following dates:

April 24, 2017, NOPEC (electric), Certificate No. 01-044(E) April 24, 2017, NOPEC (natural gas), Certificate No. 02-012(G) April 6, 2017, OSC (electric), Certificate No. 15-392(G) March 14, 2017, SOPEC (electric), Certificate No. 14-826(E)

On May 30, 2017, pursuant to PUCO policy,¹ the representative for each of the Joint Movants requested that the individual annual reports be "unlocked" to facilitate filing an amendment.² Joint Movants made their request to comply with the PUCO's Notice to Brokers, Aggregators and Governmental Aggregators issued Friday, May 26, 2017,³ and to enable them to remit their assessments as calculated by the PUCO and Office of the Ohio Consumers' Counsel. PUCO Staff granted this request and unlocked the annual reports that already had been filed by each of the Joint Movants.⁴

On May 31, 2017, Joint Movants' representative amended each of the respective annual reports and "saved" the reports as amended on the PUCO's online system. When the representative subsequently returned to formally "submit" the reports, the log in to the online
