Dear Ms. McNeal:

This correspondence is intended to supply information to supplement the German Village Society's Complaint against Columbia Gas of Ohio, Inc. Revised Attachment A presents additional German Village Residents/Columbia Gas customers that have signed individual statements of support as described in the Complaint. This now makes 103 people in German Village that would like the Commission to stop Columbia's relocation of meters to unsafe locations outside of their residences.

Attachment H, which was mistakenly and inadvertently omitted from the original German Village Society Complaint, is now attached. This Attachment is important because it plainly shows that not only is Columbia and their contractors installing meters without regard to their exposure to weather and vandalism, but it also shows that, according to Columbia's own standards, Columbia is installing meters that **violate their own plumbing requirements** that meters are kept certain distances away from ignition sources such as furnace intakes, live electric boxes and residential air conditioners. These first relocations have been undertaken in a careless manner that imperils the safety of the customers at these residences.

First German Village Meters moved outside May 17, 2017. No protection from weather or vandalism. Also note these first installations violate Columbia's own standards for plumbers when installing service lines, meters and service regulators (These FIRST four meters moved outside are located next to a furnace intake, less than 3 feet from live electric service boxes, and less than 5 feet from a working residential air conditioner. According to Columbia's own rules, this is an UNSAFE INSTALLATION). *Plumber's Guide, Section A.3.2(a)1 and 2 (2010 edition):*
