## **(Description of Proposed Trade Name Addition)**

The Applicant, The Ridgeville Telephone Company, hereby seeks the necessary approval to add the trade name "Ridgeville Long Distance" for the division of the telephone company that will offer intrastate long distance services to its customers. No existing or proposed tariff pages are affected by the addition of this trade name since long distance services are no longer permitted to be included in tariffs pursuant to Rule 4901:1-6-11(A)(2), O.A.C. and the Entry in Case No. 10-1010-TP-ORD dated January 19, 2011. Applicant understands that telecommunications services not required to be included in tariffs shall still be subject to commission oversight and regulation as provided in Chapter 4927 of the Revised Code and Chapter 4901:1-6 of the Administrative Code.

The addition of a trade name for long distance services is for marketing purposes and will not affect the Applicant's rates, terms or conditions of service since it currently does not have any long distance customers. The new trade name will make it easy for customers to clearly identify their new long distance provider.
