Dear Commissioners:

As a long-time resident of the German Village neighborhood of Columbus, I was not pleased to hear of Columbia Gas Co. plans to relocate (natural) gas meters to the exteriors of homes. While I think I can understand the preference for a simple, one-size-fits-all policy regarding gas meter relocation, I believe more flexibility than Columbia Gas is willing to exercise (per their April 25 community meeting), is called for in special circumstances, such as German Village.

In German Village, buildings are in very close proximity to one-another, and to the street and sidewalk (often abutting the public rights of way). This development pattern, and the concentration and density of the mostly-residential buildings, is unique in the central Ohio region. I believe that externally-located, bulky gas meters, and associated piping, on house after house, will create a major eyesore, taking away from the attractiveness of our community, and of individual properties.

German Village residents and the city of Columbus, over many decades, have worked hard to maintain and improve the area's appearance, and have put significant financial resources toward this goal. German Village's appearance is a core element in the neighborhood's appeal and continued success, and is why the community is widely-recognized, nationally, and why it is an important tourist attraction for the region.

Another contributing factor to the special circumstances of the neighborhood, I think, is the small-scale (front view) of most of the buildings. If they were larger buildings, perhaps the meters would be less apparent.

Finally, regarding safety, my understanding is that the natural gas meters have been in our basements for decades and I cannot recall any serious safety issues being reported during my three decades in the neighborhood. It seems to me (a non-expert) as though it could even be an advantage having them inside the house where they are sheltered, and where homeowners help to monitor and care for them.

In summary, Columbia Gas Co.'s inflexible-plan to move gas meters from our basements to the exterior, I believe, will have an adverse effect on my own property and, more importantly, on the German Village Historic District. I hope that the Public Utility Commission of Ohio, as the State's utilities regulator, will provide us some relief in this situation.
