If there is another power company, other than DP&L, that can send electric to Jamestown, Ohio, please let us know. My Mom and I, combined, have never missed a payment for a century and a half = good credit risk, in fact, we have no objection to prepaying as well.

It is an overt act of discrimination to turn off the electric supply to paying customers just because a loved one dies.

We wish to have the power turned back on to 4360 & 4269 Alleghany Trail, Jamestown, Ohio, 45335. I have been writing DP&L checks, for all billings from the 4357 home address for the last several years, spoke to them numerous, numerous, times, wrote clarifying information on the bill stubs to help clarify the situation, ^{now} it's just a ^(now) question of turning the power back on as usual or attending a formal hearing to find out why they cannot; despite overwhelming credit history and funds.

I am her son, I've helped her with the homes, over the years, was her sole caretaker the last two years, and am now caring for the homes and tenants solo; not by choice or desire, in addition, of course, to my own responsibilities, but by death. Death of my mother.

May hope, and God, allow this to be understandable. (We even paid a lot of money to have Mom's Estate Attorney contact The Dayton Power and Light Company to verify the above paragraph is accurate, in addition to the tenants, themselves, requesting that the electric bill be put back in my mother's name and address upon their relocation.)

Currently, the power is shut off at 4360 Alleghany Trail and 4269 Alleghany Trail, Jamestown, Ohio 45335. Both tenants requested to transfer billing to my Mom's address, still open, at great expense, for ease of all billing parties. Can't market/mend homes, dark/no power, catastrophic loss. Request formal hearing or power on, neither my mother, nor I, have EVER missed/been late/failed to pay ANYONE, EVER.


