FINDING AND ORDER

I. SUMMARY

{¶ 1} The Commission grants the joint petition of The Dayton Power and Light Company and Union Rural Electric Cooperative to reallocate their service territories.

II. DISCUSSION

{¶ 2} The Dayton Power and Light Company (DP&L) and Union Rural Electric Cooperative (UREC) are electric suppliers as defined in R.C. 4933.81. By Entries issued in Case No. 78-1311-EL-ORD, the Commission certified the territories of DP&L and UREC.

{¶ 3} Pursuant to R.C. 4933.83(E), two or more electric suppliers may jointly petition the Commission to reallocate their service territories and electric load centers. In their petition, the electric suppliers shall designate which portion of their territories and electric load centers will be served by each electric supplier.

{¶ 4} On April 7, 2017, DP&L and UREC jointly petitioned the Commission to reallocate their service territories in Union County, Jerome Township, Ohio. Specifically, they request the following relocation:

On Quadrangle map M-14, located in Union County, within Jerome Township, starting at the centerline intersection of Taylor Road and Industrial Parkway; thence southeast with the centerline of said

Industrial Parkway 745 feet to the north line of The Reserve at California Phase 1; Thence southwest with said north line 530 feet to a point on the existing territory line being the beginning of reallocation. Thence southeast 170 feet to the centerline of a proposed street; Thence northeast with said proposed centerline 260 feet; Thence southeast with said proposed centerline 1000 feet to a proposed cul-de-sac; Thence southwest 120 feet to the northerly corner of Lot 112 of New California Woods IX; Thence southeast with a northerly line of said Lot 112, 145 feet to a point on the existing territory line and the end of reallocation.

{¶ 5} In support of their request, DP&L and UREC explain that The New California Reserves 165 lot residential development is located on the border of DP&L and UREC service territories. Sixteen lots along the eastern side of the development are within the DP&L service territory. Due to the layout of streets in the development, the current territory border results in three of these lots within DP&L's territory being on the west side of a north-south oriented street while the other thirteen are on the east side. In order to simplify engineering line extensions and to alleviate any confusion over which company serves these lots, the Companies have agreed for DP&L to relinquish these three lots to UREC territory while UREC will relinquish three other lots in another sector of the development to DP&L.

{¶ 6} No objections have been filed to the joint petition for reallocation.

{¶ 7} The Commission finds that granting the requested relief will promote the purposes of R.C. 4933.81 to 4933.90, and will further promote the provision of adequate service to all territories and electric load centers affected by the relocation as required by R.C. 4933.83(E). Accordingly, the Commission finds that the joint petition is reasonable and should be approved.

{¶ 8} The Commission, therefore, directs that the territorial boundaries of DP&L and UREC be appropriately modified as delineated in the joint petition and the maps of the certified territories be amended accordingly.

III. ORDER

{¶ 9} It is, therefore,

{¶ 10} ORDERED, That the request of DP&L and UREC to reallocate their territory boundaries be granted. It is, further,

{¶ 11} ORDERED, That the change on quadrangle map M-14, described in the joint petition, be approved to show the boundary line change. It is, further,

{¶ 12} ORDERED, That a copy of this Finding and Order be served upon each party of record.


