Dear Ms. McNeal:

This letter is to inform the Ohio Power Siting Board ("OPSB") Staff that Dominion Energy Ohio ("DEO") is in compliance with the OPSB Staff Report of Investigation Conditions issued June 9, 2017, and as agreed to by DEO in its Supplement filed June 13, 2017.

Condition No. 1 states that prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.

In compliance with Condition No. 1, DEO submitted to Staff on June 13 2017 the attached right-of-way permit from the City of Youngstown. This permit is the only one required.

Condition No. 2 states that in the event that removal of the potential bat maternity roost tree becomes necessary, emergent survey efforts shall be coordinated with Staff and ODNR prior to removal.

There are no bat maternity roost trees that will need to be removed in the project area.

Condition No. 3 states that Applicant shall maintain traffic along public roadways and access to adjacent land uses during construction.

DEO agrees to maintain traffic along public roadways and access to adjacent land uses during construction.

Condition No. 4 states that DEO shall give notice to affected property owners in advance of construction starting along or on their property. In addition to the preliminary notice that was sent to all affected property owners on March 26, 2015, a second notice was sent on May 19, 2015.

DEO agrees to notify the affected property owners in advance of construction starting along or on the property owners' property.

I have reviewed the construction plans dated March 2017 for the above-referenced project. Your attention is called to the following items:

1. Provide Maintenance of Traffic plans as per OMUTCD manual;

- 2. Mill and fill Guadalupe Avenue (curb to curb) between Francisca Ave and Alameda Ave with 2" of Item 448 ASPHALT CONCRETE SURFACE COURSE, TYPE 1, (448), PG64-22;
- 3. Provide granular backfill for the gas line under the pavement or within 5 feet from the pavement;
- 4. Provide a sidewalk restoration detail as per City of Youngstown standard Detail; and
- 5. Any curb ramp replacement shall meet ADA requirements for the handicap ramp;




