Dear PUCO Commissioner Thomas W. Johnson,

As a resident of Blue Ash and concerned citizen, I am writing you to register my opposition to Central Corridor Pipeline Extension Project (Reference No. 16-253- GA-BTX).

This pipeline expansion project is a major safety hazard to anyone who resides or is present within the pipeline blast area; it will cause devastation to the land it will be installed in; and will result in substantial property value loss. (Some real estate brokers have estimated the property value loss as high as 30%)

As a safety hazard, if there is an explosion, (and there have been multiple instances across the United States), anyone within a 500 ft radius has a high chance of death or serious burns. There have been concerns about how the pipeline is constructed in order to prevent any leaks, how often the pipeline is monitored, and the response time by Duke Energy.

If you look at the proposed pipeline routes, the green route, crosses multiple residential areas on Glendale-Milford Rd., Reading Rd., and the new Blue Ash Summit Park, where many concerts occur, and a location where families bring their children to enjoy nature and have fun. This park has cost millions in taxes to Blue Ash residents, and as part of the project, Duke Energy will also install a pressure relief valve on that land. This green route also passes in front of the Boy Scouts Achievement Center and Gorman Heritage Farm, where children of all ages, attend meetings and overnight camping adventures to learn skills.

The alternate orange route, will not only pass thru residential areas, it will also be in close proximity to the Kenwood Towne Center, several shops and restaurants, several medical office buildings, and the Mercy-Jewish Hospital, putting thousands of patients and shoppers at risk.

Home owners will lose use of some of their property, due to the underground pipeline. Trees and other foliage will be removed, stream crossings will have to be altered, resulting in water runoff, leading to flooding. Animal habitats will also be destroyed in the process.

In addition to the above reasons why I am opposed to the pipeline, I am appalled that the OPSB wasn't even at the recent hearing to listen to these reasons.

This action demonstrates to me that the ,OPSB and Governor of Ohio, must be influenced by Duke Energy and could care less for the citizens of Ohio.

Maybe this pipeline should go thru your neighborhoods. So let's make sure this pipeline does not go thru anyone of the proposed routes, since it is not needed and is dangerous.
