- {¶1} On October 5, 2016, the Commission issued a Finding and Order authorizing CSX Transportation (CSX) to install mast-mounted flashing lights and roadway gates at the Shoemaker Road/Township Road 251 grade crossing (DOT#518300Y) in Oxford Township, Delaware County. The Commission ordered completion of the project by July 5, 2017.
- {¶ 2} On June 5, 2017, CSX filed a letter requesting 30 more days to complete the project. CSX explains that safety certification for its construction crew will prevent the crew from arriving on site until June 19, 2017. CSX anticipates that the project will be completed within two weeks of the originally scheduled date.
- {¶ 3} Staff filed a memorandum on June 8, 2017, recommending that the Commission grant 30 more days to complete the project.
- {¶ 4} Pursuant to the Commission's September 19, 1996 Entry in *In re* 1996 Federal Crossing Protection Program, Case No. 96-676-RR-FED, the Commission authorized the attorney examiner assigned to the case to grant extensions for up to 30 days.
- {¶ 5} Upon review of CSX's request and Staff's recommendation, the attorney examiner finds that a 30-day extension of time should be granted. Unless otherwise authorized, CSX should complete the project by August 4, 2017.
