{¶ 1} Staff served notices of preliminary determination upon Anthony K. Culver and Ricky M. Savoie (Respondents), in accordance with Ohio Adm.Code 4901:2-7-12, alleging violations of the Commission's transportation regulations.

{¶ 2} On February 13, 2017, Respondents filed a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.

{¶ 3} A prehearing conference was held on March 16, 2017.

{¶ 4} By Entry dated March 16, 2017, this case was scheduled for hearing on May 25, 2017. At Respondents' request, the hearing was subsequently rescheduled for August 17, 2017.

{¶ 5} On June 12, 2017, Staff filed a motion for continuance. Specifically, Staff requests that the hearing be continued for a period of 21 days, due to a scheduling conflict for one of Staff's witnesses. No memorandum contra the motion for continuance was filed.

{¶ 6} The attorney examiner finds that Staff's motion for continuance is reasonable and should be granted. At this time, the attorney examiner finds that this matter should be rescheduled for hearing on September 7, 2017, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-C, Columbus, Ohio 43215-3793.

{¶ 8} ORDERED, That Staff's motion for continuance be granted. It is, further,

{¶ 9} ORDERED, That this matter be rescheduled for hearing on September 7, 2017, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-C, Columbus, Ohio 43215-3793. It is, further,
