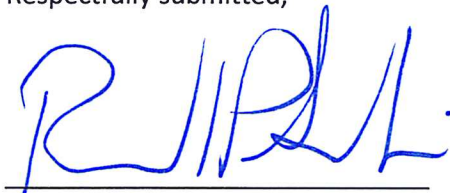
**REPORT OF SERVICE
