Re: PUCO Case No. 17-1298-GA-CSS: German Village Society v. Columbia Gas of Ohio, Inc.; Updated Attachment A and Reply to Columbia Gas of Ohio's "Response" to the German Village Society's Request for the Commission to Maintain Gas Service to German Village Residents During the Pendency of the Complaint.

Dear Ms. McNeal:

This correspondence is to update for a third time Attachment A included in the German Village Society's ("GVS") Complaint filed on May 22, 2017. This revised Attachment A now includes 154 persons that are German Village Residents/Columbia Gas customers that support the GVS's complaint regarding meter relocation in German Village. It is evident from Columbia Gas of Ohio's pleadings that the Company misunderstands the full nature and multiple interests represented by the complaint. Columbia will eventually attempt to relocate all meters in the German Village area from inside locations to outside locations. The GVS has plainly and repeatedly stated that not only are there significant safety concerns not addressed by the Company, but also historic preservation efforts and space considerations that may negatively affect all property owners, residents, Columbia Gas customers, tourists and German Village businesses. This Attachment is meant to emphasize individual support for the complaint and the correspondent temporary injunction. It is unnecessary to join these folks individually, or attempt to execute multiple complaints with the same interests. Therefore, the GVS submits this updated Attachment for the Commission's consideration.

This correspondence is also meant to address the "response" filed by Columbia Gas of Ohio on June 27, 2017. This extra-regulatory "response" is not part of the complaint process. There is no provision for it in PUCO rules, Ohio law or case precedent, and it therefore must be considered improper. However, the GVS would like the Commission to consider the Company's response and its contents, because it proves that the GVS' concerns regarding customer service terminations are well-founded.

In the "response," Columbia Gas of Ohio states that the request is moot. The Company states that it will work with the Society to address their concerns (page 2). Columbia then emphatically states that "Columbia has no plans to terminate or disconnect service to any customer on the Project due to a meter location dispute until the project is finished (Bold emphasis added) (page 2). These statements are



welcome in part (not the bold part) and GVS reiterates here that it continues to seek a cooperative resolution with the Company, and appreciates the Company's interest in resolving the case.

Yet on page 3, just as the GVS speculated in its June 23, 2017 request, Columbia states unequivocally that "the retirement of the old main eventually will result in the loss of service for [...] customers..." (Emphasis Added - page 3) [that do not allow their meters to be relocated]. Further, Columbia states the "...disconnections will not occur until September..." (page 3). Thus, per Ohio Administrative Code Rule 4901-9-01(E), Columbia has provided certain documentation that it plans to disconnect and terminate service to customers for reasons that do not involve safety or unpaid bills, but rather on behalf of Columbia's financial interests. Complaint cases may last several months. For Columbia to state that the request is moot while at the same time unequivocally stating that it plans to disconnect service – while the complaint may still be pending – justifies the original request of the GVS. The German Village Society again urges the Commission to approve to motion for a temporary injunction of any meter relocation and to approve its request that no German Village customer's service be disconnected during the pendency of this complaint case.
