Enclosed for filing is the Duke Energy Ohio ("Duke") gas cost recovery (GCR) report, as required by Section 4901:1-14, O.A.C., for the month commencing August 2017. This filing is based on supplier tariff rates expected to be in effect on August 1, 2017 and the NYMEX close of July 7, 2017 for the month of August 2017.

Duke's GCR rate effective August 2017 is \$4.695 per MCF, which represents a decrease of \$0.005 per MCF from the current GCR rate in effect for July 2017.
