STATEMENT OF VECTREN ENERGY DELIVERY OHIO, INC. INFORMING THE COMMISSION WHETHER THE ISSUES RAISED IN COMMENTS HAVE BEEN RESOLVED

In accordance with the Commission's May 5, 2017 Entry, Vectren Energy Delivery of Ohio, Inc. (VEDO) hereby submits its statement informing the Commission whether the issues raised in the comments have been resolved.

Staff filed Comments on July 20, 2017, recommending that the Commission approve VEDO's Application. (Staff Comments at 7–8.) In consideration of its comments from last year's case regarding the number of eligible contractors submitting bids, *see* Case No. 16-904-GA-RDR, Staff found that "that VEDO's contractor bidding and selection process in 2016 was fair and effective in controlling DRR costs," given "the number of contractors submitting and winning bids along with the facts that awarded bid packages contract dollars were spread out over the eligible contractors and that no contractor was awarded a disproportionate share." (*Id.* at 7) Staff raised no issues with VEDO's Application and recommended that it be approved. (*Id.* at 7–8.) No other party intervened or filed comments.

Because no issues have been raised with the Application, there are none to be resolved, and VEDO believes that a hearing in this case is unnecessary. *See* Entry ¶ 4(d) (May 5, 2017) ("*In the event* all of the issues raised in the comments are not resolved, . . . a hearing will commence") (emphasis added). Therefore, VEDO respectfully requests that the Commission approve its Application, as filed.
