We do not want natural gas meters removed from basements and placed on exterior facades in the district. It is our understanding that Federal statistical data reveals that approximately 90% of reportable incidents involving gas meters from 2010 to 2017, involved gas meters on the EXTERIOR of buildings. This is terrifying. As I write, Columbia Gas of Ohio continues to move meters to the exterior in the Village.
