In accordance with Paragraph 9(b) of the May 25, 2017 Entry issued by the Ohio Power Siting Board ("OPSB") in the above-captioned proceeding, Aspire Energy ("Aspire") submits the following issues for consideration and possible cross-examination at the hearing in this matter:

- 1. The location of the facility, as set forth in the application and referenced in Condition 1 proposed by the OPSB staff in the Staff Report filed on July 31, 2017, which states that "[t]he facility shall be installed at the Applicant's proposed site...."
- 2. The statement by Guernsey Power Station, without evidence of consent from Aspire, that the Aspire natural gas line that is located on the facility footprint would be relocated and that Aspire would manage the permitting and approval process prior to relocating the line. (See Application at 121).
- 3. Other issues that may arise in this matter that are related to the property where Guernsey Power Station is proposing to build its facility, which may infringe on Aspire's rights, including, but not limited to: its right to maintain, operate, repair, replace, change the size of, and remove its existing pipeline; and its continuing right to lay, maintain, operate, repair, replace, change the size of and remove additional lines of pipe.

Aspire reserves the right to raise additional issues based on testimony and issues raised during cross-examination.
