I was unable to attend the OPSB local hearing on Tuesday, August 15th at Meadowbrook High School, but I would like to submit a statement of support for the Guernsey Power Station Project.

This type of project has both local and national benefits. First relative to climate change, natural gas is helping combat climate change by lowering carbon dioxide emissions. As coal fired power is being reduced and removed from the power grid, natural gas is domestically produced, provide jobs to the region, as well as, energy independence to the country.
