{¶ 1} The Dayton Power & Light Company (DP&L) is a public utility as defined under R.C. 4905.02 and, as such, is subject to the jurisdiction of this Commission.

{¶ 2} On November 30, 2015, DP&L filed an application for an increase in rates, pursuant to R.C. 4909.18.

{¶ 3} On March 22, 2017, the Commission issued an Entry directing Staff to issue a request for proposal (RFP) for the necessary audit services for review of the application. The RFP provided that the draft report of the audit be presented to Staff by September 4, 2017. Subsequently, on April 19, 2017, the Commission selected Blue Ridge Consulting Services, Inc. (Blue Ridge) to conduct the accounting review of the application.

{¶ 4} On August 29, 2017, Staff filed a motion for extension of time, proposing to extend the deadline for the presentation of the draft audit report to Staff from September 4, 2017 to September 18, 2017.

{¶ 5} The attorney examiner finds that Staff's motion is reasonable and should be granted. Accordingly, the deadline for the presentation of the draft audit report to Staff will be extended to September 18, 2017.

{¶ 6} It is, therefore,

{¶ 7} ORDERED, That the deadline for the presentation of the draft audit report to Staff be extended to September 18, 2017. It is, further,

{¶ 8} ORDERED, That a copy of this Entry be served upon all parties of record.
