On September 5, 2017, Trishe Wind Ohio, LLC ("Applicant") filed a Notification of Compliance with Condition 24 of the Supplement. Condition 24 of the Supplement requires the Applicant to provide the final delivery route plan and the results of any traffic studies to Ohio Power Siting Board ("OPSB") staff and the Paulding County Engineer 30 days prior to the preconstruction conference.

In order to simplify wind turbine deliveries, certain routes have been eliminated from the Turbine Delivery and Public Intersection Plan, which Applicant included in page 4 of its September 5, 2017 filing. Therefore, the Applicant is providing the revised delivery route map, which is attached hereto, and which supersedes and replaces the map included in page 4 of the September 5, 2017 filing titled Turbine Delivery and Public Intersection Plan.


