

MEMORANDUM IN SUPPORT

By entry of July 26, 2017, the Commission granted the Motion filed by Eastern Natural Gas Company and Pike Natural Gas Company on May 31, 2017, and suspended the collection of the demand-side management rider rates, until the Commission specifically orders otherwise.

In the interim, the Commission directed that the Companies, Staff and OPAE should meet to discuss and evaluate the Companies' DSM weatherization programs. The Companies, Staff and OPAE recently met and are attempting to achieve a consensus on the direction that the Eastern and Pike DSM programs should take.


The Commission also directed that initial comments and reply comments be made on September 15 and 29, 2017, evaluating the Companies' DSM programs, including recommendations to revise or discontinue the DSM programs or initiate other energy efficiency or conservation programs.

Because the parties have met, have engaged in informative discussions and are attempting to reach a consensus on the direction these programs should take, there is no need for the filing of direct and reply comments at this time. The Companies assure

the Commission that they will continue to work with OPAE and the Staff in an attempt to address the direction of such programs. Eastern and Pike will keep the Commission informed. Neither the Staff nor the OPAE object to this motion. Good cause exists for granting the indefinite suspension of such comments.

WHEREFORE, Eastern and Pike move that the Commission suspend indefinitely the initial and reply comments that were scheduled to be filed on September 15 and 29, 2017 in this matter.


