Re: PUCO Case No. 16-1842-RR-FED - In the Matter of a Request for the Installation of Active Warning Devices at CSX Transportation Inc. Grade Crossing, DOT# 518-300Y, on Shoemaker Road in Delaware County, Ohio.

On September 6, 2016, the Ohio Rail Development Commission (ORDC) authorized construction for CSX Transportation, Inc. (CSX) to install warning devices at the following location:

Street	DOT#	County	Railroad	Project
Shoemaker Road/TR 251	518-300Y	Delaware County	CSX	Lights and Gates

On October 5, 2016, the Commission issued a Finding and Order approving the project and ordering completion by July 5, 2017. CSX had issues getting power service installed at the crossing. This crossing has two different electric companies at the crossing and the provider was based on what side of the crossing where the power service was located. This took a while for CSX to work out with the two electric companies. The completion deadline was extended until September 5, 2017.

The crossing project has been completed and is in-service:
