**MOTION FOR EXTENSION**

Pursuant to Rule 4901:1-27-09(B) of the Ohio Administrative Code, Viridian Energy PA LLC ("Viridian") seeks an extension of Certificate No. 13-324G (2) which was issued in Case No. 13-1838-GA-CRS. The expiration date of Certificate No. 13-324G (2) is September 23, 2017. Due to the delayed availability of an exhibit, Viridian was not able to file its renewal application on time. It has now filed its renewal application on September 22, 2017 which is one calendar day prior to the September 23, 2017 expiration date. Viridian respectfully requests that Certificate No. 13-324G (2) be automatically extended from September 23, 2017 until October 22, 2017 or until the date that the renewal certificate is issued.

WHEREFORE, Viridian Energy PA LLC respectfully requests that Certificate No. 13-324G (2) be automatically extended to October 22, 2017 or until a renewal certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review.


**MEMORANDUM IN SUPPORT OF

Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. Viridian submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 13-324G (2) issued in Case No. 13-1838-GA-CRS to October 22, 2017 or until such time as a renewal certificate is issued.
