Re: PUCO Case No. 16-2181-RR-FED- In the Matter of a Request for the Installation of New Active Warning Devices at the Norfolk Southern Railway Railroad Crossings, Albany Street DOT# 524-626D & Washington Street DOT#524-622B, in Montgomery County, Ohio.

On October 31, 2016, the Ohio Rail Development Commission (ORDC) authorized funding for Norfolk Southern Railway to install new lights and gates at Albany Street (DOT# 524-626D) & Washington Street (DOT#524-622B), in Montgomery County, Ohio.

The crossings were surveyed on May 3, 2011 and were found to warrant the upgrades.

On December 21, 2016, the Commission issued a Finding and Order approving the projects and requiring project completion by September 21, 2017.

On September 7, 2017, Norfolk Southern Railway (NS) filed an extension request for the projects (see attached). In the request NS indicates that they have completed all work possible, but are waiting on CSX Transportation (CSX) to coordinate and resolve circuitry issues at the crossings. There is a CSX track adjacent to the NS tracks on Washington Street that is to be upgraded, but CSX has not yet received authorization from ORDC for its design.

Staff consulted with ORDC about the status of the CSX project and the design submitted by CSX has not yet been approved. ORDC supports placing the project in abeyance until CSX can complete their portion of the work that affects the NS crossing.

Staff therefore recommends that the Commission put the project in abeyance and require NS to complete their portion of the work within 60 days of CSX's completion of the related crossing work.

MEMORANDUM IN SUPPORT

By "Finding and Order" of December 21, 2016, the Commission authorized NSRC to install new lights and roadway gates at the Albany Street (524626D) and Washington Street (524622B) grade crossings in Dayton, Montgomery County, with an assigned project completion deadline of September 21, 2017.

Substantial progress has been made – specifically, NSRC has completed its related construction, in that new equipment has been installed, etc. But because the existing circuitry is interconnected with CSX's, NSRC cannot place the new equipment in-service, unless and until CSX resolves outstanding OUPS concerns, receives authorization to proceed from the ORDC, and completes its related work, following which the existing NSRC/CSX circuitry can and will become separated.

In light of the above, NSRC respectfully requests that it be granted an extension of time of sixty (60) days within which to complete the respective construction projects – specifically,

to place the newly-installed equipment into service, with this clock to begin ticking once CSX has confirmed the completion of its related work.
