APPLICATION OF LYKINS OIL COMPANY DBA STEP RESOURCES TO AMEND ITS ANNUAL REPORT FOR CALENDAR YEAR 2016

Lykins Oil Company dba STEP Resources ("Lykins") is authorized to provide electric aggregation and power broker services in this state pursuant to Certificate No. 09-183(E)(4), which was issued by the Commission on December 15, 2015 in Case No. 09-1813-EL-AGG.

Pursuant to the Commission's February 1, 2017 entry in this docket, Lykins filed its annual report for calendar year 2016 on May 15, 2017. However, as the result of a recent internal review, Lykins has determined that it understated the brokerage fees and commissions realized during 2016 in reporting its revenue. Accordingly, by this application, Lykins requests leave to amend its 2016 annual report to show the correct amount of brokerage fees and commissions. Because it is not possible, as this juncture, to access the web-based filing system for submitting annual reports, Lykins has attached a hard copy of its amended annual report to this application.

Lykins recognizes that the change in the reported 2016 revenue will affect the amount of the PUCO maintenance assessment due November 1, 2017. Unless instructed otherwise by the Commission staff, Lykins will pay its estimate of the adjusted amount of the PUCO assessment on or before the due date.
