MEMORANDUM IN SUPPORT

Pursuant to Rules 4901-1-12 and 4901-1-13 of the Ohio Administrative Code, Ohio Power Company ("AEP Ohio") respectfully moves for a short, approximately one-week extension of the procedural schedule in this proceeding and a like continuance of the evidentiary hearing presently scheduled to begin November 20, 2017. Because the deadline for AEP Ohio's direct testimony is November 1, 2017, AEP Ohio also requests an expedited ruling in this matter pursuant to Ohio Adm. Code 4901-1-12(C).

On June 29, 2017, the Attorney Examiner issued an Entry establishing the following procedural schedule in these proceedings:

- November 1, 2017 Deadline for AEP Ohio to file testimony
- November 9, 2017 Deadline for intervenors to file testimony
- November 15, 2017 Deadline for Staff to file testimony
- November 20, 2017, at 10:00 a.m. Evidentiary hearing commences
 Entry at ¶ 24 (June 29, 2017).

The parties have engaged in settlement negotiations that may resolve one or all disputes issues between some or all of the parties. In order to facilitate continued settlement discussions and explore whether a partial or complete settlement may be reached, AEP Ohio requests an approximately one-week extension of the testimony deadlines set forth above and a continuance of the current hearing date. Specifically, AEP Ohio requests that the Attorney Examiner modify the procedural schedule in this case as follows:

- November 8, 2017 Deadline for AEP Ohio to file testimony
- November 16, 2017 Deadline for intervenors to file testimony
- November 21, 2017 Deadline for Staff to file testimony

• November 28, 2017, at 10:00 a.m. – Evidentiary hearing commences

If a partial or complete Stipulation and Recommendation ("Stipulation") is filed by two or more parties before November 8, 2017, then AEP Ohio requests that the Attorney Examiner further modify the above procedural schedule at that time in order to accommodate the preparation of testimony in support of the Stipulation, possible preparation of testimony in opposition to the Stipulation, and the parties' preparation for hearing.

All parties have been contacted regarding this motion and AEP Ohio's request for expedited ruling. No party opposes either the motion or AEP Ohio's request for immediate ruling.

Accordingly, AEP Ohio respectfully requests that the Attorney Examiner issue an entry extending and continuing the procedural schedule in these proceedings as set forth above.
