On October 13, 2017, the Ohio Power Siting Board (“OPSB”) Staff issued a Report of Investigation approving the Construction Notice. In is Construction Notice, filed on September 29, 2017, Dominion Energy Ohio (“DEO”) stated under Section 4906-6-05 (B)(9)(a), Operating Characteristics, Required Structures and Right-of-Way and/or Land Requirements (page 5), DEO indicated:

The temporary construction materials laydown areas will be necessary and will be determined after the bid has been awarded to the construction contractor.

DEO has now selected is construction contractor, 1127 Construction. 1127 has selected a laydown area that is located at 3840 Greentree Southwest, Canton, OH as shown on the map below. The land that 1127 has arranged to lease temporarily is from New Down Real Estate LLC. The laydown area can be accessed from Greentree SW.

However, there are delineated wetlands to the west and a stormwater basin to the north of the proposed laydown area (all of which are identified on the SWPPP mapping for the project) that may need protected by sediment control devices depending on the size of the laydown area.
