**VINTON SOLAR ENERGY LLC’S RESPONSES TO THE  
SECOND SET OF INTERROGATORIES  
FROM THE STAFF OF THE OHIO POWER SITING BOARD**

On July 5, 2017, as supplemented on August 16, 2017, Vinton Solar Energy LLC (“Applicant”) filed an application (“Application”) with the Ohio Power Siting Board (“OPSB”) proposing to construct a solar-powered electric generation facility in Vinton County, Ohio (“Project”).

On October 18, 2017, the Staff of the OPSB (“OPSB Staff”) provided the Applicant with OPSB Staff’s Second Set of Interrogatories. Now comes the Applicant providing the following responses to the Second Set of Interrogatories from the OPSB Staff.

**1. How many residences are within 1,000 feet of the project area?**

**Response:** There are 46 residences within 1,000 feet of the Project area. However, there are only 11 residences within 1,000 feet of the fence that will enclose the facility.

**2. Of those residences, how many are within 100 feet of the project area?**

**Response:** There are 8 residences within 100 feet of the Project area. None of these residences are within 100 feet of the fence that will enclose the facility.

3. **Based on current lay-out, what is the estimated distance of the nearest residence to an above ground solar array facility?**

**Response:** The closest residence is 444 feet from the fence enclosing the facility.
