{¶ 1} Duke Energy Ohio, Inc. (Duke) is a public utility as defined by R.C. 4905.02.As such, it is subject to this Commission's jurisdiction.

{¶ 2} On June 1, 2017, Duke filed an application for a standard service offer (SSO) in the form of an electric security plan pursuant to R.C. 4928.141 and R.C. 4928.143.

{¶ 3} The attorney examiner issued a procedural schedule on July 21, 2017. Testimony on behalf of intervenors would be due by October 30, 2017; testimony on behalf of Staff would be due by November 6, 2017; and an evidentiary hearing was scheduled to begin on November 13, 2017.

{¶ 4} On October 26, 2017, Staff filed a motion for an extension of the procedural schedule and a request for expedited treatment. Staff requests additional time in order to facilitate negotiations between the parties and to pursue a possible settlement. Staff maintains that only the Ohio Energy Group opposes the motion.

{¶ 5} The attorney examiner finds good cause exists to grant Staff's request. Accordingly, the procedural scheduled will be adjusted as follows:

- (a) Testimony on behalf of intervenors should be filed by November 9, 2017.
- (b) Testimony on behalf of Staff should be filed by November 16, 2017.
- (c) As notice of the hearing has already been published, the evidentiary hearing will commence as scheduled on November 13, 2017, and then be continued until November 28, 2017, at 10:00 a.m. at the offices of the Commission, 180 East Broad Street, Hearing Room 11-A, Columbus, Ohio.

{¶ 7} ORDERED, That Staff's motion for an extension of the procedural scheduled be granted. It is, further,

{¶ 8} ORDERED, That the procedural scheduled be extended in accordance with paragraph 5. It is, further,
