RE: Verde Energy License Updates – Modify Technical Personnel to Electric License 11-5886-EL-CRS (12-489E(2)) and Gas License 13-2164-GA-CRS (13-334G(2))

To Whom It May Concern:

This letter is sent as a follow-up to my letter of July 28, 2017, a copy of which is attached ("Initial Letter"), regarding Material Changes to Electric License 11-5886-EL-CRS (12-489E(2)) and Gas License 13-2164-GA-CRS (13-334G(2)) issued to Verde Energy USA Ohio, LLC ("Verde"). As a result of the transactions described in the Initial Letter, Verde makes the additional updates to its licensing filings described below.

Regarding Electric License, 11-5886-EL-CRS (12-489E(2)), Exhibits C-4 and D-3 have the following updates: The services previously provided to Verde pursuant to agreements with Shell Energy North America ("Shell Energy") have been discontinued. As described in the Initial Letter, Verde, together with its affiliates and parent company, were acquired in July of this year by Spark Energy and its affiliates. As part of that transaction, the contractual relationship with Shell Energy North America was terminated, and Spark Energy and its affiliates are now providing the services previously provided by Shell Energy. As an example, Chris Leonard, Vice President of Supply at Spark Energy, is contributing his considerable experience to supply management. Accordingly, Verde's management team will continue to have the requisite technical, managerial and financial capabilities to operate as a competitive electric and gas supplier.

Regarding Gas License, 13-2164-GA-CRS (13-334G(2)), similar updates will be filed pursuant to Verde's annual relicensing filing on or before November 6, 2017.

To Whom It May Concern:

Verde Energy USA Ohio, LLC ("Verde") submits this letter as notice to the Public Utilities Commission of Ohio ("Commission") that Verde was acquired Spark Holdco, LLC with ultimate ownership residing in Spark Energy, Inc. ("Spark") effective July 1, 2017. Under the transaction Verde is wholly owned by Spark Holdco, LLC. Spark has 39.47% Managing Membership Interest in Spark HoldCo, LLC. This notice is provided in accordance with OH ADC 4901:1-24-11, to notify you of a change in control of the entity licensed under Docket No. 11-5886-EL-CRS on March 29, 2012 and the entity licensed under Docket No. 13-2164-GA-CRS on December 9, 2013.

Pursuant to the transaction, neither Verde nor Spark intend to make any changes in Verde's services or customer population for the foreseeable future, other than changes made in the ordinary course of business. Verde will continue to be operated consistent with past practice for at least 18 months following July 1, 2017. The transaction will be a non-event for customers: Verde will not be changing rates as a result of the transaction, existing management will continue to operate Verde, the Verde name will continue—this is not an assignment or sale of Verde's customer contracts—and the current customer experience with Verde will remain the same. While the current officers of Verde have resigned their offices, they will continue to serve actively as part of Verde's management team, which team will now also include personnel from Spark who are experienced in operating retail electricity suppliers in many states, including in Ohio. Accordingly, Verde's management team will continue to have the requisite technical, managerial and financial capabilities to operate an electric supplier company.
