RENEWAL CERTIFICATION FILING INSTRUCTIONS COMPETITIVE RETAIL NATURAL GAS SUPPLIERS

I. *Where to File:* Applications should be sent to: Public Utilities Commission of Ohio (PUCO or Commission), Docketing Division, 180 East Broad Street, Columbus Ohio 43215-3793.

II. *What to File:* Applicant must submit one original notarized application signed by a principal officer and three copies, including all exhibits, affidavits, and other attachments. All attachments, affidavits, and exhibits should be clearly identified. *For example, Exhibit C-10 should be marked "Exhibit C-10 - Corporate Structure."* All pages should be numbered and attached in a sequential order.

IMPORTANT REQUIREMENT: *The renewal application must be docketed in the applicant's original GA-CRS case number. Therefore, applicant should enter that number on the renewal application form when filing a renewal application.*

III. *When to File:* Pursuant to Rule 4901:1-27-09 of the Ohio Administrative Code, renewal applications shall be filed between 30 and 60 days to the prior certificate's expiration date.

IV. *Renewal Application Form:* The renewal application form is available on the PUCO Web site, www.puco.ohio.gov or directly from the Commission located at: Public Utilities Commission of Ohio, Docketing Division, 180 East Broad Street, Columbus, Ohio 43215-3793.

V. *Confidentiality:* An applicant may file financial statements, financial arrangements, and forecasted financial statements under seal. If these exhibits are filed under seal, they will be afforded protective treatment for a period of six years from the date of the certificate for which the information is being provided.

An applicant may file a motion for a protective order for other information not filed under seal per the previous paragraph. If the motion is filed in conformance with rule 4901:1-27-07 of the Administrative Code, it shall be automatically approved on the thirty-first day after the date of filing and the information shall be afforded protective treatment for a period of six years from the date of the certificate for which the information is being provided, unless the commission or an attorney examiner appointed by the commission rules otherwise.

At the expiration of the six-year period provided for in the previous paragraphs, the information will be automatically released into the open record. An applicant wishing to extend a protective order beyond the six-year time period must comply with paragraph (F) of rule 4901-1-24 of the Administrative Code.

VI. *Commission Process for Certification Renewal:* An application for renewal shall be made on forms approved and supplied by the Commission. The applicant shall complete the

appropriate renewal form in its entirety and supply all required attachments, affidavits, and evidence of capability specified by the form at the time an application is filed. The Commission renewal process begins when the Commission's Docketing Division receives and time/date stamps the application. An incomplete application may be suspended or rejected. An application that has been suspended as incomplete will cause delay in renewal.

The Commission may approve, suspend, or deny an application within 30 days. If the Commission does not act within 30 days, the renewal application is deemed automatically approved on the 31st day after the official filing date. If the Commission suspends the renewal application, the Commission shall notify the applicant of the reasons for such suspension and may direct the applicant to furnish additional information. The Commission shall act to approve or deny a suspended application within 90 days of the date that the renewal application was suspended.

Upon Commission approval, the applicant shall receive notification of approval and a numbered, renewed certificate that specifies the service(s) for which the applicant is certified and the dates for which the certificate is valid. Unless otherwise warranted, the renewed certification designation will remain consistent with the previously granted certification. For example, a certified marketer will renew as a certified marketer.

Unless otherwise specified by the Commission, the competitive retail natural gas service (CRNGS) supplier's renewed certificate is valid for an additional period of two years, beginning and ending on the dates specified on the certificate. The applicant may renew its certificate in accordance with Rule 4901:1-27-09 of the Ohio Administrative Code. CRNGS suppliers, which include marketers, shall inform the Commission of any material change to the information supplied in a renewal application within thirty (30) days of such material change in accordance with Rule 4901:1-27-11 of the Ohio Administrative Code.

VII. *Contractual Arrangements for Capability Standards:* If the applicant is relying upon contractual arrangements with a third-party, to meet any of the certification requirements, the applicant must provide with its application all of the following:

- ☐ The legal name of any contracted entity;
- ☐ A statement that a valid contract exists between the applicant and the third-party;
- ☐ A detailed summary of the contract(s), including all services provided thereunder; and
- ☐ The documentation and evidence to demonstrate the contracting entity's capability to meet the requirements as if the contracting entity was the applicant.

IX. *Governing Law:* The certification/renewal of CRNGS suppliers is governed by Chapters 4901:1-27 and 4901:1-29 of the Ohio Administrative Code, and Section 4929.20 of the Ohio Revised Code.

4. Posting a Letter of Credit with the LDU(s) as the beneficiary.



Verde Energy USA OHIO, LLC's Company History

Verde Energy USA Ohio, LLC ("Verde OH" or "Applicant") was organized as a limited liability company on November 4, 2011 in the State of Delaware.

Verde OH is an authorized Competitive Retail Electric Supplier in Ohio, effective March 29, 2012-License 12-489E (1), and has been actively serving electric customers since then.

In the first half of 2017, Verde OH began serving natural gas customers with Columbia Gas of Ohio, Dominion Ohio Energy and Duke Energy Ohio. Verde OH currently intends to engage in the business of supplying natural gas customers in all territories within Ohio by December 1, 2018.

Prior to July of 2017, Verde OH was a wholly-owned subsidiary of Verde Energy USA Holdings, LLC ("Verde Holdings") and operated pursuant to administrative service agreements with Verde Energy USA, Inc., another wholly-owned subsidiary of Verde Holdings. Verde OH, Verde Energy USA, Inc. and the other Verde branded companies (other than Verde Holdings) are referred to herein as the "Verde Companies".

In July of 2017, Verde OH, along with the other Verde Companies, was acquired by Spark Energy, Inc. ("Spark") and its affiliates. Verde is now wholly-owned by Spark Holdco, LLC. Spark has a 39.47% Managing Membership Interest in Spark HoldCo, LLC.

The Verde Companies still provide and support competitive retail electricity and natural gas services to customers in eight states: Connecticut, Illinois, New Jersey, Pennsylvania, Ohio, New York, Massachusetts and Texas behind approximately fifty (50) electrical and natural gas distribution companies. The Verde Companies also have licenses in Maryland and the District of Columbia, but they are not presently servicing customers in those states. The Verde Companies are headquartered in Norwalk, Connecticut and have provided retail electricity and natural gas to both residential and non-residential customers since 2009.

- Contracts/Services

Verde OH will provide competitively priced gas products and will comply with all applicable laws and rules of the Public Utilities Commission of Ohio ("Commission"). Verde OH is committed to providing the same high level of retail gas services as the Verde Companies already provide to retail electric and gas customers in Connecticut, New Jersey, Pennsylvania, Illinois, Massachusetts, New York, Texas and Ohio ("Service States"). Verde OH will register with local distribution companies and perform EDI testing through its EDI provider. Verde OH will market fixed and variable rate products with various features intended to meet clients' needs. Verde OH will market to all customer classes including residential, commercial & industrial customers. Verde OH will disclose to customers, in clear and understandable language, the terms and conditions of its customer contracts, such as pricing, right to terminate and switching provisions.

- Billing

Verde OH's billing services will be provided in conjunction with the other Verde Companies. The Verde Companies currently operate under a contract with a third-party provider, which supports the necessary EDI billing transactions for Service States' customers. The third-party provider also provides support for Verde OH's natural gas customer billing processes. The generation of bills and handling of billing disputes will be managed internally; billing disputes have historically been responded to in 1-2 business days. The Verde Companies intend to be operating with the same third-party provider, but under the contract with such provider held by Spark Holdco, LLC.

Verde OH will use consolidated billing whenever possible unless the customer/product dictates that Verde OH bill for natural gas charges separately. Verde OH's billing practices will comply with all Commission regulations.

- Customer Inquiries

Verde OH commits to maintaining a fully trained staff of representatives to fulfill the needs of its customers. Verde OH will comply with all sections of Chapter 4901:1-29-08 - *Customer access and complaint handling* of the Ohio Administrative Code. Verde OH will handle customer complaints. Verde OH is very proficient in accepting customer inquiries and responding to complaints. Verde OH has applied and established Inquiry Handling Procedures that are in line with Chapter 4901:1-29-08 relating to complaint handling processes. Verde OH has historically responded to inquiries within 2 business days.

Verde Energy USA OHIO, LLC's Summary of Experience

Verde OH is currently an authorized Competitive Retail Electric Supplier effective March 29, 2012-License 12-489E (1), and has been actively serving electric customers in Ohio since then. Verde OH is also currently an authorized Competitive Retail Natural Gas Marketer effective December 5, 2013; it began serving customers with Columbia Ohio Gas, Duke Energy Ohio, and Dominion Energy Ohio in the first half of 2017. The Verde Companies have been actively marketing electricity and natural gas in jurisdictions with retail electric and natural gas supplier certification requirements that are similar to Ohio's since 2009 and will support Verde OH in bringing these same services to the state of Ohio. The Verde Companies presently have 40 employees and have contractual relationships with service providers who support its retail electric and natural gas businesses which serve about 200,000 electric and gas accounts in over fifty utilities that span over eight different states. Pursuant to the transaction, neither Verde nor Spark intend to make any changes in Verde’s services or customer population for the foreseeable future, other than changes made in the ordinary course of business. Verde will continue to be operated consistent with past practice for at least 18 months following July 1, 2017. The transaction will be a non-event for customers: Verde will not be changing rates as a result of the transaction, existing management will continue to operate Verde, the Verde name will continue – this is not an assignment or sale of Verde’s customer contracts – and the current customer experience with Verde will remain the same. While the current officers of Verde have resigned their offices, they will continue to serve actively as part of Verde’s management team, which team will now also include personnel from Spark who are experienced in operating retail electricity suppliers in many states, including in Ohio. Accordingly, Verde’s management team will continue to have the requisite technical, managerial and financial capabilities to operate an electric supplier company.
