**MOTION FOR PERMISSION TO APPEAR *PRO HAC VICE***  
**AND SUBSTITUTION OF COUNSEL**  
**OF THE UNITED STATES DEPARTMENT OF ENERGY**

Pursuant to Gov.Bar R. XII(2)(A)(6), Rishi Garg (“Movant”), attorney for the United States Department of Energy (“DOE”), hereby moves the Public Utilities Commission of Ohio (“the Commission”) to grant Rishi Garg permission to appear *pro hac vice* and participate as counsel or co-counsel in this case for approval of the termination of the Letter Agreement between DOE and Ohio Valley Electric Corporation (“OVEC”).

Mr. Garg represents that he is licensed to practice law in the District of Columbia; that his date of admission to the District of Columbia Bar was March 9, 2012 and that his District of Columbia Bar attorney registration number is 1006506.

Mr. Garg further represents that he has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year pursuant to Gov.Bar R. XII(2)(A)(5).



Mr. Garg also requests that the Commission substitute Mr. Garg as counsel of record or co-counsel in this case in place of Mr. Steven A. Porter and provide here written notice of Mr. Porter's withdrawal from this case pursuant to the Commission's Rules of Practice 4901-1-08.



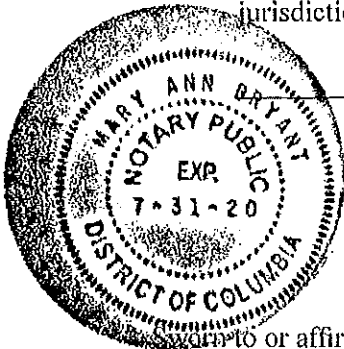
