## P.U.C.O. No. 17 ELECTRIC DISTRIBUTION SERVICE ECONOMIC DEVELOPMENT RIDER

Ohio Law allows for the recovery of costs incurred as a result of economic development and job retention programs including foregone revenues. The rates and charges listed below are designed to recover the cost incurred in DP&L's service territory. The cost associated with these programs may change over time based on customer participation. Pursuant to the approved Amended Stipulation and Recommendation in Case No. 16-395-EL-SSO, DP&L will provide economic development incentives to the identified eligible customers. The total amount of the incentives provided will be recovered in this Rider. The Economic Development Rider shall be assessed on kilowatt-hours (kWh) of electricity per tariff class distributed under this Schedule at the rates stated below, effective on a bills-rendered basis in the Company's first billing unit for the month of November 2017.
